

# Carli Charters Camping Contract

This agreement states that Carli Charters will transport up to six people and their camping gear to a Washington State Park or a San Juan County Park for the purpose of camping.

Carli Charters agree to meet campers in Friday Harbor, Washington at slip 8 Port of Friday Harbor Spring Street Landing on date; \_\_\_\_\_ at \_\_\_\_\_ a.m/p.m. Carli Charters agrees to transport campers to Island campsite in a safe and reasonably timed manner. Carli Charters agrees to return to above mentioned campground on date; \_\_\_\_\_ at \_\_\_\_\_ a.m/p.m for purpose to pick up campers and gear and return them to Friday Harbor in a safe and timely manner.

Campers agree to pay Carli Charters \$ \_\_\_\_\_ (full price for round trip charter) before departing Friday Harbor. A pre-paid deposit of \$ \_\_\_\_\_ which is non-refundable if campers cancel within 25 days of charter will be applied to balance.

- Campers understand that Carli Charters offers boat transportation only. No camping gear, food or any supplies are included in this agreement, all supplies, gear, food, are campers responsibility.
- Camping gear will be limited to a total weight of two hundred and fifty pounds or what will reasonable fit in one vehicle.
- Campers agree to be fully packed and ready to leave on designated date and time, if Carli Charters must wait for campers to be ready Carli Charters will charge campers at the rate of \$100.00 an hour with a 1/2 minimum.
- Campers understand that camping fees, clean up and garbage removal are their responsibility.
- Carli Charters strongly recommend that campers agree to bring along with them one hand-held VHF radio to be used for emergencies only and to be supplied by Carli Charters. Carli Charters will charge to credit card number used to hold this reservation \$100, if campers loose, break or destroy said VHF radio. If campers decide not to accept use of radio please initial and date here \_\_\_\_\_.
- Carli Charters recommends campers discuss with medical authority the use of anti-histamines or other medicines in case of anaphylactic shock( bee-stings, food allergies, etc.)
- Campers and or assigns agree to hold harmless Carli L.L.C. for any accidents, damages, liabilities, physical injury or deaths that may occur during or after Charter.
